Ordinance 2023 - Lo

Adopting Stop Signs on Bonebrake Road in Fountain County, Indiana

Whereas, the Fountain County Board of Commissioners, under its general police powers, is responsible for traffic safety, which includes setting forth the locations of stop signs on county roads; and

Whereas, a citizen of Fountain County, Indiana has petitioned to the Fountain County Board of Commissioners for the addition of stop signs at the intersection of Bonebrake Road and Kingman Road for northwest and southeast traffic; and

Whereas, the Fountain County Sheriff and Fountain County Highway Department Director support adding that the northwest and southeast traffic at the intersection of Bonebrake Road and Kingman Road proceed with a stop sign; and

Whereas, the Fountain County Sheriff and Fountain County Highway Department Director support adding a stop sign for northbound traffic on County Road 100 West at its intersection with Bonebrake Road; and

Whereas, the Fountain County Board of Commissioners finds, after due inspection, that the stop signs at the intersection of Bonebrake Road and Kingman Road, northwest and southeast, along with a stop sign for northbound traffic on County Road 100 West at Bonebrake Road should be added to promote the safety and welfare of the citizens of Fountain County; and

Whereas, the Fountain County Highway Director should take all steps to add the designated stop signs and markings at these locations to carry out the intent of this ordinance;

Therefore, it is ordained that the County Traffic Code is amended to provide for the addition of stops signs at the intersection of Bonebrake Road and Kingman Road, northwest and southeast.

It is further ordained that the County Traffic Code is amended to provide for the addition of a stop sign for northbound traffic on County Road 100 West at its intersection with Bonebrake Road.

It is further ordained that the Sheriff's Department shall be notified by the County Highway Director of the addition of these stop signs. It is further ordained that this ordinance shall take effect upon the adoption by the majority of the Fountain County Board of Commissioners.

It is further ordained that all provisions of the Fountain County Code of Ordinances that are not specifically amended by this ordinance, including but not limited to all other stop intersections previously established by ordinance, shall remain in full force and effect.

It is further ordained that this ordinance shall become effective upon adoption and publication under Indiana law.
