SOLAR FARM – request regarding permits

These 4 parcels of property is owned by Winterberg, LLC, by Erich K. Lang, M.D.; Managing Partner. The project would be 1,800 feet of frontage on the south side of State Rd 28 and would be about 288 acres in size.

Tim Shumaker advised that the Plan Commission take no action at this time so that they can get some clarification on if the City of Attica or if the County would be responsible for doing the paperwork on this request.

Innovative Solar Systems, LLC. is also interested in 3 other parcels for a Solar Farm in Richland Township with the same request from the County Plan Commission. This property is owned by Jason & Kelly Carlson. The project is about 34 of a mile north of Newtown, on the East side of State Rd 341 would be about 200 acres in size. No action was taken.
