D. Report of Committees and Officers – Discussion on Who needs to be reappointed for 2024 at the next meeting. Kyle Crowders term is up. - **Permit Fees** – Board went over each permit and decided on what fee to set. Board Members debated on Solar Permit fees changes. Jim McKee asked to have it put on record to increase permit fees for Solar. Jamie Shonkwiler also requested that we mirror the Wind Ordinance and also consider changing Solar to a Special Use and not allowing it to be permitted in Agricultural Land. Tim Shumaker expressed his concerns that increasing solar fees could affect the Economic Development Money that the County

would receive from the Solar Companies, and that the Commissioners will not change the current Solar Ordinance. He recommended to have the Commissioners appear at the next meeting to continue the discussion.

- **Mailer-** Amber Roarks notified the board that the mailers have been ordered and should reach residents around the first week of January. She was also able to use that same flyer and create post cards to send out to land owners that live outside the county and rural land owners that live in city municipals.




