## Notice of Public Hearing to Consider Proposed Amendments to the Zoning Ordinance for Fountain County, Indiana

The Fountain County Plan Commission will hold a public hearing on Thursday, September 26, 2019, at 6:00 p.m. to consider the adoption of proposed amendments to the Zoning Ordinance for the County. The meeting will be held in the Fountain County Courthouse's Council Chambers, 2<sup>nd</sup> floor, 301 Fourth Street, Covington, Indiana 47932. The proposed amended Zoning Ordinance, if adopted, will apply to all unincorporated areas in Fountain County.

The proposed amendments to the Zoning Ordinance amend established agricultural, residential, commercial and industrial zoning districts in the unincorporated areas of Fountain County. The proposed amending ordinance also revises established procedural rules for applications for rezones, text amendments, appeals and enforcement. The proposed amending ordinance also revises certain established permitted uses, special exceptions for use and development standards for each district. The proposed amending ordinance also revises established regulations for wind turbine zoning, siting, set-backs, and other matters. The proposed amending ordinance provides that wind turbines are allowed only as a special exception in industrial districts and are not permitted in other zoning districts. The proposed amending ordinance establishes other rules and regulations to provide for efficient development of land in Fountain County.

The proposed ordinance contains the following penalty provisions:

**VIOLATIONS AND PENALTIES:** Any structure or use that violates this Ordinance shall be deemed to be a common nuisance and the owner of the structure or land shall be liable for maintaining a common nuisance. Any person or legal entity that is found by a Court of competent jurisdiction to have violated any provision of this Ordinance may be fined not more than Two Thousand Five Hundred Dollars (\$2,500.00) per offenses, plus costs, and attorney fees where the action is not brought pursuant to I.C. 36-7-4-1013, and have judgment entered accordingly.

Citizens appearing at the public hearing will have an opportunity to provide comments concerning the proposed Zoning Ordinance. All interested citizens are encouraged to attend. The Plan Commission may continue the hearing from time to time as may be found necessary. Citizens may file written objections with Auditor Brenda Hardy, 301 Fourth Street, Covington, Indiana 47932 before the public hearing. All such written objections will be considered by the Plan Commission.

A copy of the proposed Amended Zoning Ordinance is on file and may be examined at the Fountain County Auditor's office at 301 Fourth Street, Covington, Indiana 47932 (765-793-6243), office hours are 8:00-4:00 weekdays except holidays.
